**EPIC'S CREEL PEG EXTENSION
FOR PACKAGE TUBES ON VOLKMANN 050C
BA3, BA4, AND BA5 CREELS
PROVIDING SIGNIFICANT COST SAVINGS**

Problem: In the plant, there is no place to keep piece packages without the risk of contaminating the yarn. Putting them on the floor creates a trip/fall hazard and increases the chance of yarn contamination. If piece packages aren't run out in the creel, they either become waste, or have to go through another process (back winding) to make them into a full package to be run normally. While back winding is effective, it is one more step to add to the manufacturing process. It requires time, people, and machinery, which drives up the department CPP (cost per pound) and slows down production.



Solution: The Epic EE440400 creel peg gives the operator a safe, clean place to put the piece packages that are generated in the cabling process. It improves efficiency and safety by providing a straightforward storage location for partial and empty packages, reducing the need for buggies and keeping yarn off the floor. They are conveniently located out of the operator's way, yet ergonomically friendly.

Installation is easy. They fit existing setup with no brackets required. The customer removes the bolt that holds the bottom package centering and black plastic bottom plate. They then slide the creel peg extension into the creel tube and re-install the aforementioned items to complete the installation. Epic's EE440400 Creel Peg Extension was designed to hold (not run) a piece package until it is ready to be run out in the creel. Of course it can also be used to hold an empty tube if desired. It is not a third creel position, capable of running yarn. It is merely a place to hold piece packages until they are ready to be run in their proper position, the top, horizontal, position of the creel.

The EE440400 creel peg design will not work on 05C Narrow Gauge machines. EE440400 is designed to fit inside tubing that is 27mm X 27mm. Please contact us if you are interested in a modified version to accommodate your situation.
